COURSE OVERVIEW

This course addresses the causes of losses and lawsuits including employee injuries (workers' compensation), auto liability, general liability and employment practices liability, as well as pre-employment and fitness for duty evaluations. In particular, the latest court trends and decisions impacting police agencies will be reviewed along with particular approaches to improve operations.

This course will fulfill the MEL requirement that the Police Chief and at least one other senior command officer from each member police department complete a risk management course by May 1, 2010 for the town to remain eligible for the premium and deductible incentives under the MEL employment practices liability policy. MEL members can send unlimited additional command officers to be trained and there will be no course fee for MEL members. (All police agencies are invited to attend this training)
